It also includes other types of rights, such as trade secrets, publicity rights, moral rights, and rights against unfair competition. Artistic works like music and literature, as well as some discoveries, inventions, words, phrases, symbols, and designs can all be protected as intellectual property.</p> <p>Major Intellectual Property</p> <p>Copyright Copyright is a legal term describing rights given to creators on their literary and artistic works.</p> <p>Related Rights Rights granted by law to communicators of works to the public</p> <ul style="list-style-type: none"> ◦ Performers ◦ Broadcasting Organizations <p>Performer’s Rights It includes recording, broadcasting and communicating to the public of a live performance. Its duration is about 50 years.</p> <p>Patent A patent is an exclusive right granted for an invention, which is a product or a process that provides a new way of doing something, or offers a new technical solution to a problem. The limited monopoly right granted by the state enables an inventor to prohibit another person from manufacturing, using or selling the patented product or from using the patented process, without permission. The time period of patent is about 20 years.</p> <p>Trademark A trademark is a distinctive sign which identifies certain goods or services as those produced or provided by a specific person or enterprise.</p>
