Women's human rights are abused when they cannot participate in decisions that affect their lives and are denied political participation and fair representation. When they are prevented from going to school or receiving health care, when they face discrimination in employment, when they are denied equal rights to own land and property, when they suffer from violence within their homes and when they are subjected to harmful traditional practices such as genital mutilation and honour killings.</p> <p>The discussion went on with the importance of women in this society. The law's and procedure for protection was addressed. The seminar concluded with a Q&A round by the speaker. Finally concluded with the vote of thanks.</p>
