

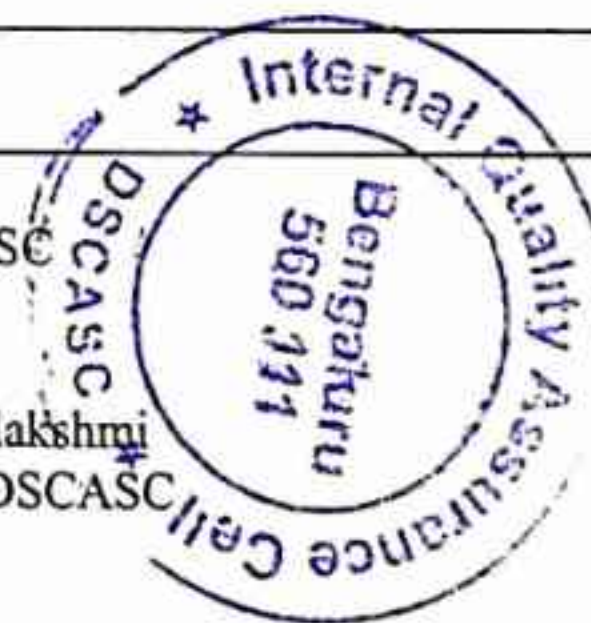

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding [MOU] is made on this day 15/10/2025

BY AND BETWEEN

Samashti Foundation #22, Embassy Tranqui, Alit # 403, 8th main 3rd Block, Koramangala, Bangalore-560034, Karnataka, represented by Founder, Samashti foundation

AND



Principal, Dayananda Sagar of Arts Science and Commerce, Bangalore representing Pruthvi- Eco club, DSCASC, Kumaraswamy Layout, Bangalore-560078 are individually referred to as party and jointly referred as parties.

- 1 The parties wish to enter into Memorandum of Understanding [MOU] for establishing collaborative activity center with activities such as
 - 1.1 Involve and train the interested undergraduate, post graduate students of DSCASC for conservation of nature.
 - 1.2 DSCASC will organize Guest Lectures, Industrial Visits, Seminars/ Workshops for the undergraduate, post graduate students of DSCASC and Samashti Foundation shall extend their guidelines and also their cooperation and support in this regard.
 - 1.3 Training / Internship/ certification courses will be arranged for undergraduate, post graduate students of DSCASC at particular premises as decided mutually. Samashti Foundation will be providing the platform for the internship/training/certification programmes. DSCASC can extend administrative and infrastructure support in this context with/without financial implications.
 - 1.4 Mutually the parties will support in promoting Interests, Creativity and Ethics among Students/nature lovers.
 - 1.5 Samashti Foundation shall render all the help in organizing hands on training sessions to undergraduate, post graduate students of DSCASC.
 - 1.6 Samashti Foundation shall extend their support to DSCASC in delivering technical talks and training sessions for the undergraduate, post graduate and faculties of DSCASC.

2 Duration, Amendment and Termination:

- 2.1 This MOU shall be valid for a period of one year from the effective date. During the period of its validity, MOU can be amended any time by mutual consent or by either party giving the other a written notice of its desire to terminate the MOU by giving one month notice in advance.
- 2.2 Notwithstanding any termination, the MOU shall continue to survive and be effective with regard to all rights and obligations of the parties which existed prior to the termination of this MOU until such rights and obligations have been fulfilled into.
